JANUARY LUNCHEON

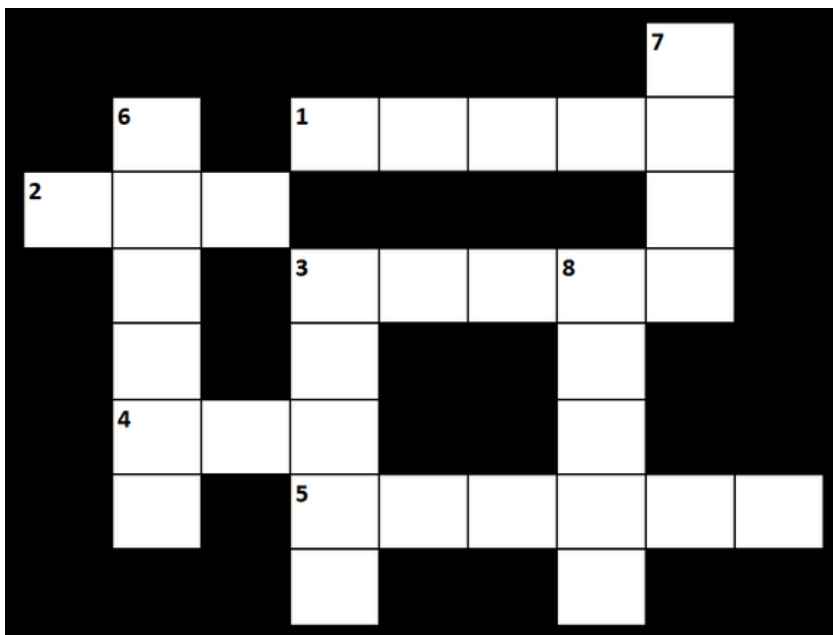

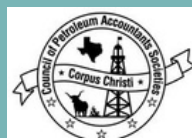
